Installed 5 vaccine refrigerators and 15 street lights in villages in remote Northern Benin and conducted monitoring and evaluation  
of 24 new water stations installed in Benin at the end of 2021. In cooperation with partner Rape Hurts Foundation in Uganda,  
procured 5 solar ovens and provided training to village women to allow them to bake goods for sale to support their safe house.  
Installed solar systems in homes of 4 families in the Colonias region of South Texas with 10 more planned for next year. Provided  
Solar training for Native Americans in Southern California. Worked with the World Health Organization (WHO) to monitor and  
troubleshoot vaccine refrigerators throughout the world. SELF also continued to provide remote monitoring and repairs on solar  
powered direct drive vaccine refrigerators throughout Haiti.
